

Mr. Smith served as Australian Permanent Representative to the United Nations at Geneva and Ambassador to the Conference on Disarmament between 2002 and May 2006. In 2004, he was, concurrently with his other responsibilities, Chairman of the UN Commission on Human Rights.

Between 1998 and 2002 Mr. Smith was Chief of Staff to Alexander Downer MP, Minister for Foreign Affairs. Other positions Mr. Smith has held in the Australian Department of Foreign Affairs and Trade include: Assistant Secretary of the Corporate Planning and Evaluation Branch (1998), Legal Adviser and Assistant Secretary for Refugees, Immigration and Asylum (1991-93) and Head of the Multilateral and Humanitarian Legal Section (1984-86).

Overseas, in addition to his most recent position in Geneva, Mr. Smith served as Ambassador to Egypt and Sudan (1995-98), Minister (Political) in the Australian Embassy in the United States (1993-95), Ambassador to Algeria and Tunisia (1989-91), Counsellor in the Australian Permanent Mission to the United Nations at Geneva (1986-89), and served as First Secretary while in Syria (1981-84) and Second Secretary while posted in Egypt (1977-79). Visiting professor in Addis Ababa University (1978–81,1986–1989) and Nottingham University (1992). Lecturer in the NATO Defence College (2004 – Rome).

Member of the Advisory Legal Committee to the Minister of Foreign Affairs of Poland; chief specialist on legislative matters in the Legal Department of the Ministry of Internal Affairs and Administration of Poland - since 1993.



Peter NEUMANN

Director of the International Centre for the Study of Radicalisation and Political Violence (ICSR) King's College London

Dr. Peter Neumann is the Director of the International Centre for the Study of Radicalisation and Political Violence. Prior to this appointment, he was Director of the Centre for Defence Studies (2005-2007) at King's College London, and Content Director of the International Summit on Democracy, Terrorism and Security (2004-2005) organized by the Club de Madrid, the association of former Presidents and Prime Ministers.

Dr. Neumann is the co-author of *The Strategy of Terrorism* (Routledge 2008) and has recently published an *Adelphi Paper* titled 'Joining Al Qaeda: Jihadist Recruitment in Europe' (IISS, 2009). Previous publications include *Britain's Long War* (Palgrave MacMillan, 2003), a comprehensive assessment of British strategy in the Northern Ireland conflict, as well as numerous articles on terrorism and radicalization in journals like *Survival, Foreign Affairs, Orbis*, and *Terrorism and Political Violence*.

His forthcoming book - *Old and New Terrorism* - will be published by Polity Press during 2009. Opinion pieces and shorter analyses have appeared in the *New York Times*, the *International Herald Tribune*, *Prospect* and other magazines and newspapers. Dr. Neumann frequently appears on radio and television as an expert on terrorism and political violence.

Dr. Neumann is a senior lecturer in War Studies at King's College London and teaches classes on terrorism, insurgency, radicalization, and intelligence. He is Co-Director of the newly created Master's Programme in Terrorism, Security and Society.

Dr. Neumann went to university in Berlin, Belfast and London. He received an MA in Political Science from the Free University of Berlin and a PhD in War Studies from King's College London.

Dr. Neumann is a member of the Club de Madrid's expert advisory council, as well as of the editorial boards of the journals *Studies in Conflict and Terrorism* and *Democracy and Security*. He is an Affiliate of the European Commission's European Network of Experts on Radicalisation, serves as a member of the German Federal Criminal Office's (BKA) European Expert Network on Terrorism Issues, and is associated with several other institutions and think-tanks.

Before becoming an academic, he worked as a radio journalist in Germany.

Michael JACOBSON

Mr. Michael Jacobson is a senior fellow in The Washington Institute's Stein Program on Counterterrorism and Intelligence. His areas of focus include sanctions and financial measures to combat national security threats, as well as other issues related to counterterrorism, national security law, and intelligence reform. From September 2004 to June 2005, he worked as a Soref fellow at the Institute, authoring the monograph The West at War: U.S. and European Counterterrorism Efforts, Post-September 11.

Mr. Jacobson rejoins the Institute from the Treasury Department, where he served as a senior advisor in the Office of Terrorism and Financial Intelligence (TFI) from June 2005 to March 2007. In that capacity, he fulfilled a wide range of responsibilities, including involvement in the office's strategic planning, priorities, and budget. He was also a liaison to TFI's congressional oversight committees, to the Office of the Director of National Intelligence, and to the National Counterterrorism Center.

Previously, he served as counsel on the 9-11 Commission, where he was assigned to two teams: one that focused on domestic intelligence policy issues, and another investigating the September 11 plot. In addition to his work with the commission, he served as counsel with the Congressional September 11 investigation, participating in the team that assessed the FBI's performance.

Mr. Jacobson also worked for the FBI for more than five years, first as an intelligence analyst, then as assistant general counsel in the Office of the General Counsel. He holds a bachelor's degree in psychology from Brandeis University, a master's degree in international relations from Tufts University, and a law degree from Boston College Law School.

In March 2009, Ms Quéméner also elaborated the report for the European Certificate on Cybercrime and Electronic Evidence (ECCE).

The European Certificate on Cybercrime and Electronic Evidence (ECCE) is a European project cofinanced by Cybex and the European Commission, which aims to give technical training on cybercrime and electronic evidence to judges, prosecutors and European and Latino-American lawyers.


Keith VERRALLS

Detective Inspector, Scotland Yard United Kingdom

Detective Inspector Keith Verralls has 33 years experience as a police officer, serving with both the Metropolitan Police in London and on attachment to the National Crime Squad for England & Wales. The majority of his service has been spent investigating serious and organised crime, ranging from murder to international drug trafficking.

In 2004, Keith Verralls was posted to the Counter Terrorism Command (formerly known as the Anti Terrorism Branch) based at New Scotland Yard. There he currently leads one of the Command's enquiry teams, investigating terrorist offences in the United Kingdom and against British citizens overseas. In this position he has played an important role in many of the high profile investigations that have taken place over the past 5 years, including that into the transport bombings in London.

Since October 2005, he has been responsible for the conduct of an enquiry into terrorist use of the internet. This has led to the first successful prosecution in the UK for incitement to commit acts of terrorism through the medium of the internet (case of Tsouli & others). "



Javier GÓMEZ BERMÚDEZ

Magistrate President of the Criminal Chamber Audiencia Nacional Spain

Magistrate Javier Gómez Bermúdez, born in Málaga, Spain, in 1962. After passing his State examinations, he became a judge in 1987, and Magistrate in 1989. He has been Magistrate at the Criminal Section of the Audiencia Nacional since 1999, therefore he has 21 years experience as regards penal trials, including terrorism. Since September 2004 onwards he has presided over the Criminal Section of the Audiencia Nacional, the Spanish special Court for terrorism offences.

As far as terrorism is concerned, he has been Magistrate raporteur in many of the trials against the ETA cupule arrested in Bidart, France, and also in the trial against the group who bombed the Chamartín train (Christmas 2003); the murders of Mr. Gregorio Ordóñez and Mr. Miguel Ángel Blanco (members of the Spanish Conservative Party), and Mr. Eduardo Madina (member of the Spanish Socialist Party).

He has been Magistrate raporteur for the resolutions adopted as regards procedures against SEGI-JARRAI, GESTORAS PRO AMNISTIA-ASKATASUNA and all those procedures concerning the so called "ETA entorno" and the financial support of ETA, including cases of ETA blackmail to basque businessmen and other extorsions.

He has been also Magistrate raporteur in procedures against members of the terrorist groups GRAPO and GIA.

As regards jihadi terrorism, he has taken part in more than ten procedures regarding this specific kind of terrorism. He has been the chairman person of the Court that proceeded against the so called Spanish Al-Qaeda cell and therefore, the Magistrate who condemned Emid Edwin Barakat Yardas, alias "Abu Dadda" and others (Dátil Operation or Dixon CAse, for instance).

He has been the chair person of the Court that judged the 11th March terrorist attacks in Madrid, the biggest terrorist crimes ever committed in Spain. He has also a wide experience on youth terrorism, on prison treatment of terrorist detainees and organised crime and city vandalism.

Mr. Gómez Bermúdez has been awarded with the IV Premio Internacional COVITE (to those acting in favour and supporting of victims of terrorism); the "Medalla de Plata al Mérito Social Penitenciario" (social award by the prison service) and the "Premio de la Asociación Andaluza de Víctimas Terrorismo" (prize the awarded by Association Andalousian of Victims Terrorism).

He is also an assistant Lecturer of Criminal Law and Procedural Law, European University in Madrid (since 2005) and an instructor at the Madrid Bar Association and Andalousian School for Public Safety.

Mr. Gómez Bermúdez is also author of different publications concerning terrorism: "Levantando el velo", Cie Inversiones, 2006; "El significado político de las víctimas del terrorismo: el valor del Estado de derecho y de la ciudadanía", Fundación Fernando Buesa, 2005; "Últimas reformas penales", Cuadernos del Poder Judicial, 2006; "las víctimas del terrorismo en el discurso político", Fundación Miguel Ángel Blanco, Dilex.



PANEL 3 – THE POTENTIAL FOR CYBER ATTACKS BY TERRORISTS

Moderator



Raphael Francis PERL

Head of the Action Against Terrorism Unit Organization for Security and Co-operation in Europe (OSCE)

Mr. Raphael Francis Perl currently holds the position of Head of the Action against Terrorism Unit of the Organization for Security and Co-operation in Europe (OSCE). Prior to assuming his current position, Dr. Perl served as the senior analyst for terrorism policy with the Congressional Research Service of the Library of Congress in Washington, D.C.

A graduate of Georgetown University's Foreign Service and Law Schools, he is the author of more than 100 congressional and academic publications, including *National Strategy for Combating Terrorism: Background and Issues for Congress* (Congressional Research Service CRS 2007), *Combating Terrorism: The Challenge of Measuring Effectiveness* (CRS) 2007), *International Terrorism: Threat, Policy, and Response* (CRS, 2007), *Trends in Terrorism: 2006* (CRS, 2006), and *Combating Extremist Ideologies: Measuring Effectiveness Considerations for Public Diplomacy* (Connections, Winter 2006).

Dr. Perl speaks regularly at academic institutions and international and governmental policy fora; has testified before Congress on terrorism policy issues, including the 9/11 Commission Report recommendations; and has addressed the U.N. General Assembly on the role of regional organizations in implementation of its global counter-terrorism strategy. Under his leadership the OSCE Action against Terrorism Unit has redoubled its efforts in combating terrorist use of the Internet and has begun to explore options for comprehensively enhancing cyber security.

Dr. Perl frequently speaks at and moderates expert meetings on these topics. As an Adjunct Professor at George Washington University, he taught a graduate course on global terrorism. As a fellow at the National Academies, he was project director for an interdisciplinary team involved in assessing terrorist risk. He is actively involved with the U.S. National Research Council and the U.S. National Academy of Engineering, as well as the Russian Academy of Sciences in projects to combat terrorism in Russia. He also serves on a "brain trust" advisory group to the United States National Counter Terrorism Center charged with making recommendations on monitoring terrorist trends.

Dr. Perl speaks German and has a good working knowledge of French.

Andrea CAVINA

Nuclear Information Security Officer IAEA – Office of Nuclear Security

Mr. Andrea Cavina is the Nuclear Security Information Officer in the Office of Nuclear Security, International Atomic Energy Agency (IAEA). He comes from a former career as a research physicist having mostly being involved in solid state and laser physics research at the University of Bologna, Italy and at the *Ecole Polytechnique Federal de Lausanne*, Switzerland.

His work for the IAEA Office of Nuclear Security focuses on issues of Information Management and Information Security. In particular, in the latter field he is responsible for the development of the Information and Computer Security programme. This includes:

- 1) two guidance instruments —"Computer Security at Nuclear Facilities" and "Protection and Confidentiality of Nuclear Security Information"—which will be soon published within the IAEA Nuclear Security Series;
- 2) a series of International workshops focusing on the above guidance and striving to divulgate best practices in information and computer security to IAEA Member States and
- 3) Advisory services to help States assess the quality of their protective measure in place.
